After the discertation following our last entry, I knew right away we had to come up with a few answers. First off, I shall decipher the Greek message appearing in our last article.

NOW in rebutal, regards this thing was called "BJ" appearing at numerous in-tervals in the text. By exchanging it for "but" I assure you it sure would sound silly Don't you agree?

Therefore let us assume "BT" does not mean "but" nor does it mean "Bulletin". We had to do some extensive research on it and come up with the following.

"BT" sent as dah dididit dah or -...according to international Morse Code, it is a "double dash" or the "break sign". Since the double dash is only used when sending some mathamatical problem via international morse and is used as we say 2 times 2 equals 4. Here it would be used to save time by exchanging it with "equals" in the equation, or as we always see it, a double dash.

(Research check) The 1948 ARRL Handbook, chapter 21 has quite a bit on "BT" and its use in traffic handling. Newer issues have discontinued this. We were just fortunate to have the items on our book shelf.)

Now since the invention of the international morse code (it was an in-Vention you know") there have been few arithmatic classes held over the air, and when there were, problems that arose, the double dash was always spelled out as "equals".

Therefore today its use is singular and is the "Break sign". This does not refer to the "break, break, break, etc" business you hear on the phone bands by some lid who forgot he had a station call issued him. The break sign" in this case is used to break up or change the train of thought being transmitted. Just as the period ( . ) is used in writing. Let us not forget, punctuation has its place in amateur radio C.W. transmission but down through the years saving time and speeding things up have been number

It is common practice by commercial rediogram stations as well as the ARRL to place the break sign "BT" after .. the preamble of the radiogram and before the address, then again between There are pleasures to be expected

the address and the text of the message and again between the text and the signature of the sender. Here we can: readily see if the punctuation mark "period" were used it would involve quite a bit of confusion because the operator et the other end would not know if the address was to be part of the text or not.

In conclusion we can see that down through the years the "BT" has left its "double dash" drop and is nothing more than a good substitute for a comma or period. I hope we have enlightened a few on this discertation and if interested, will bring out a few more strange items on the art of "see-double-yew" in a future edition.

COMMENTS ON SIX AND TWO

By SMEL A. RHAT

Recently, the FCC announced that asof June 6, 1960, the frequencies of 50.0 to 50.1 Mcs and 147.9 to 148 Mcs will be reserved exclusively for CW operation. So take heed and pass the word---no more phone operation after the above date in the sub bans so allocated.

Some like the ruling and others do not. It remains to be seen whether it is a decision which really reflects the imposition of the desires of a minority group. It will be interesting to observe for example, how often the 50.0 to 50.1 segment will remain unused, during band openings, while the rest of the band is active on phone. The ruling affects U.S. amateurs only, as far as is known at present, so don't be surprized to hear Canadians, Mexican and other non U.S. phone stations in the first 100 kc segment of the 6 meter band.

also, like not hearing our old memisis "Testing Titus" who always got his dirty work in during aurora sessions, and it will also be nice to work the CW aurora without some individual clobbering the whole first 100 kc with an overmodulated phone signal.

It is not understood just why the top 1.00 kc of the Two meter band was allocated for CW only, particularly since 144.0 to 144.1 Mcs is now almost exclusively CW by common consent of the operators that use the band. selection of top 100kc sure leaves the technicians and the novices out in the cold as far as opportunity to work an exclusively CW band. It seems to me that the deliberate flouting of these amateur grades in this respect, is not in keeping with the policies of either the FCC or ARRL--both aparently are promoting the use of CW as a prime requisite to obtain a General ticket. It will be interesting to note whether Two Meter CW gang shift their activities to the high end of the band--my bet is that they stay at the low frequency end.

Now that the decision has been made, the best thing we can all do is to pitch in and take advantage of what it offers. Here is your chance to get going on CW, get extra multipliers on the VHF contest, and maybe get a chance to work some DX that you might never hear or work on phone.

There have been several good aurora openings lately and on at least two of them South American stations were heard at the same time. Heard one of the locals working a California station the other evening, so look for the double hop contacts during those openings toward the southwest and northeast.

By the time you read this, Ladies Nite will be history and I hope that all of you thatwent enjoyed it. See you next month.

Therefore it can be assumed that the FCC figured that they were getting enough CW from the other bands, and thereby allocated the high end of the band for CW to the General or Advanced Ticket holders.

#### FIELD DAY RULES

1-ELIGIBILITY: The Field Day is open to all radio amateurs in the sec-, tions listed on page 6 of QST.

\*\*\*\*\*\*\*\*\*\*\*

- 2-08JECT: For Portable and mobile stations to work as mony stations as possible; for home stations to work as many portable and mobile stations as possible.
- 3-CONDITIONS OF ENTRY: Each entrant agrees to be bound by the provisions of this announcement, the regulations of his licensing authority, and the decisions of the ARRL Contest Committee.
- 4-ENTRY CLASSIFICATION: All entries will be classified according to the maximum number of transmitters at any one time in simultaneous operation. They will be further classified as follows: "A", club or group portable stations; "B", unit or individual portable stations; "C" mobile stations; "D", home stations operating from emergency power; "E", home stations operating from commercial power sources. Thus a club or group running three transmitters simultaneously will be in class 3A classification, or a mobile station (Cont'd )

#### FIELD DAY RULES (contid)

with one transmitter will be in the 1C classification.

Portable stations are those installed temporarily, for FD purposes, at sites away from customary fixed-station locations. Portable equipment or units must be placed under one call and the control of one licensee, for one entry. All control locations for equipment operating under one call must lie within a 1000-foot diameter circle.

Group participation is that portable station work accomplished by 3 or more licid. ops. Unit or individual participation is that portable-station work accomplished by either 1 or 2 licensed operators.

Mobile stations are complete installations including power source and antenna, mounted in or on vehicles and capable of being used while in normal motion. If they utilize antenna supports not normal or suitable for use during motion, installation must be classified as portable instead of mobile. Each mobile entry must be different from any other FD station participation.

Home-station participation is that work by fixed amateur stations not operating portable or mobile.

A transmitter used to contact one or more stations may not subsequently be used under more than one other station call during the Field Day period.

- 5-FIELD DAY PERIOD: The field Day opens at 4:00 P.M. EST (or 1 P.M. PST)
  June 25. In the following 27-hour p
  period, operation can be for any consecutive 24 hours. Operation can start everywhere at 4 P.M. 5 P.M.,
  6 P.M. or 7 P.M. EST, for example, but contemplates 24 hours continuous work for the test, all work of all stations concluded at 7 P.M. EST or earlier, on June 26. All contact s must be made during a 24-hr. period.
- 6-BANOS Each phone and C.W. band is regarded as a separate band. The following (and) additional u.h.f.-s.h.f. bands) constitute separate bands. A1: 1.800-1.825 "east" or 1.975-2.000
- "west", 3.5-4.0 .....50-54 and 144148 Mc. A2: radioteletype and frequency—shift keying are grouped with A1, in the bands where they are allowed. A3: .....50-54 and 144148 Mc. A11 forms of voice transmission will be grouped with A3, in the bands where they are allowed. The use of more than one transmitter at one time in the same band is not allowed.
- 7-EXCHANGES: Signal reports and ARRL section (or specific location) must be exchanged in proff of contact.
- 8-VALID CONTACTS: In class A,B, and C,

a valid contact is a completed exchange with any amateur station.
In Classes D and E, a valid contact
is a completed exchange with any
station in Class A,B, and C. Cross
band contacts are not allowed.
Contacts by mobile stations may be
made in motion or from any location.
A station may be worked more than
once only if additional contacts
are made on different bands.

Message is one originated by a class A.B., or C station and addressed to the SEC or SCM (see address on page 6 in QST.) stating number of operators, the field location, and the number of AREC members at the Field Day station. Only one Field Day Message may be originated for credit.
